



“Shopping Treats” 2021 Campaign
11 June to 4 July 2021

1. Shop and Redeem Promotions

Shoppers will enjoy these exclusive promotions from **11 June to 4 July 2021**:

- Tier 1** Spend \$30 in a single receipt on weekdays to receive \$4.50 worth of parking rebate.
Limited to the first 35 shoppers per weekday, Mondays to Fridays. Fairprice Finest receipts require double spending to meet the minimum spend criteria.
- Tier 2** From 18 June, spend \$80 in 2 same-day receipts from any Retail or F&B shops to receive a \$5 Dining Coupon.

Terms and conditions:

- Redemptions are available at the Level 1 Concierge Desk, from 11am to 9pm daily.
- Only 1 parking coupon can be used per exit to off-set the parking charges.
- All promotions are limited to one redemption per shopper per day regardless of total amount spent exceeding qualifying purchase amount.
- Each qualifying receipt can only be used **ONCE** for each redemption of gifts or vouchers.
- This promotion is mutually exclusive with other ongoing promotions, i.e. Receipts used for redemption of the “\$5 Dining Coupon” cannot be used for the redemption of the any other ongoing promotions, and vice versa.
- All redemption items are available on a first-come-first-served basis and while stocks last.

- Shoppers must be at least sixteen (16) years of age as at 11 Jun 2021 to participate in any promotions or redemption events forming part of the Promotion. The Organiser reserves the right to request for proof of age at any time.
- Scarlet Rewards card, original receipts and charge slips must be presented during redemption. Duplicate/re-printed receipts will not be accepted.
